Who Represents the State?

This is a question that is fundamental in public international law. It gives rise to questions of legal theory, and whether and how law must reflect political reality in order to be effective. New situations that call into question who represents a particular State are to be examined for whether a change in practice has occurred, or whether simply a new manifestation of a long-running issue has arisen.

The recent situation in relation to Venezuela is the latest situation giving rise to this question. It has caused complications in legal proceedings: although the Maduro Government is in power, the Guaidó Government has been recognised by around 50 countries as the rightful government of Venezuela. Both governments have sought to be heard before courts and tribunals, including ICSID tribunals and the English courts.

The issue is one that implicates States beyond the State whose government is uncertain. The old concepts of recognition gain new prominence at such times. But diplomatic recognition is an executive action, derived ultimately from a political assessment, albeit often with legal consequences. The legal significance of the question "Who represents the State?", therefore, is one on which a variety of actors in public international law have an influence.

His monograph, *Statehood and the State-Like in International Law* (Oxford University Press, August 2019), presents a new theory of statehood and personality in international law, drawing on jurisprudence, on the history of legal interaction between Western and non-Western entities, and on insights about recognition by other states. He has worked as a solicitor in Australia and on cases in the International Court of Justice and other international forums.

Sam Wordsworth specialises in public international law and international arbitration. He is regularly instructed by Governments in international cases and has appeared before numerous international tribunals including the International Court of Justice and Tribunals constituted with respect to the Law of the Sea. He also advises regularly on international law matters, and is co-author of Halsbury's Vol. 61 "International Law and Foreign Relations" and a co-author of the forthcoming Oppenheim's *International Law* 10th ed.
